The last day of our Summer Program is August 2. Beginning August 5 the Club will be open 1-6pm.

Members are allowed to sign themselves out only if parent consent is given on our summer registration form. The Boys & Girls Club of Buena Park does not accept phone calls as a form of consent. Please plan accordingly.

The Boys & Girls Club of Buena Park opens promptly at 7a.m. and closes promptly at 6p.m. Being late simply will not be tolerated and will be grounds for your child's membership being cancelled. The Boys & Girls Club of Buena Park will not assume responsibility for any child dropped off early.

Daily fees are due by the end of each week. Payments not received by the end of the day on Friday will incur a \$10 late charge. In addition, there is a \$25 fee for all returned checks. In order for your child to remain in the program all accounts must be kept current.

There are no refunds given for registration fees or field trips.

Field trips have a set number of spots available and are filled on a first come first serve basis. Payment must be made when signing up for the trip. No spots will be held. Field trip signups end two business days before the scheduled date. No refunds will be given.

Equipment found to be damaged or broken through negligence of a club member must be paid for by the parent.

Swimming field trips are on select Wednesdays, starting June 12th. Swimming trips are for ages 8 & up and each member is required to pay \$2. Due to safety concerns, each swimming trip will be limited to the first 40 members. Signups are on a first come first serve basis and will start each swimming day at 7a.m. Spots cannot be held for future days or called in by phone.

***Due to staffing and field trip schedules, some swimming trips may be cancelled without notice.**

Parents must send members to the Club with a packed lunch clearly marked with their child's name or bring food during our lunch hour (11:45a-12:45p). Members may only leave the Club for lunch with a parent's written consent.

Due to Health Code restrictions, we are unable to cook or heat up food for members.

Because of limited space, we are unable refrigerate member's lunches.

If the injury or illness is life threatening or in need of emergency treatment, I authorize the Boys & Girls Club of Buena Park to summon any and all professional emergency personnel to attend, transport, and treat the participant and to issue consent for any x-ray, anesthetic, blood transfusion, medication, or other medical diagnosis, treatment, or hospital care deemed advisable by, and to be rendered under the general supervision of, any licensed physician, surgeon, dentist, hospital, or other medical professional or institution duly licensed to practice in the state in which such treatment is to occur.
- 3) I knowingly waive any claim against, or right to sue, the Boys & Girls Club of Buena Park, its agents, officers, employees, and Boys & Girls Clubs of America for any injury, accident, illness, or death occurring during or by reason of the field trip excursion, and further waive any possible allegation or claim of liability of the Boys & Girls Club of Buena Park. I hereby acknowledge that this field trip is not required and that attendance is voluntary. I have carefully read this form and fully understand its contents, and by signing below, agree to this full and complete release of liability. This authorization shall remain effective until 8/4/19 unless sooner revoked in writing delivered to the Boys & Girls Club of Buena Park.
